#### Subscription Notes

- <u>Subscriptions</u> Subscriptions are payable on 1 October for a whole calendar year. No refunds are
  provided for any reason during the membership year. If you are a member of another Knutsford
  Sports Club section and pay your Main Club fee via that section then please subtract the £29 that
  you will have already paid.
- 2. <u>Pro Rata Fees</u> The membership year is 1 Oct 30 Sep the fee is pro-rated by month
- 3. <u>Joining Fees</u> Payable by all new members, re-joining members or members paying after the month's grace period post 31 October
- 4. <u>Juniors</u> Members must be under 18 on 1 October in the year of application. The parent/guardian for all junior members must complete the Junior Squash Parent Consent Form which contains parental contact and medical information for the Junior Secretary (Graham Woods)
- 5. <u>Rules of The Club</u> By applying for membership, you agree to be bound by the Knutsford Squash Club Rules, which are available on request and on the Squash Club website
- 6. <u>Data Protection</u> Your data will not be shared with any third party for marketing or commercial purposes. Please note that we will only publish a child's first name, unless we have the additional consent of their parent/ guardian
- 7. <u>Gift Aid</u> The bill payer must be a UK tax payer in the current tax year to allow the club to claim.

#### **General Notes**

- 1. <u>Guests</u> Only senior members can bring guests
- 2. <u>Court Fees</u> Court fees are included in the membership cost, no additional fees are payable to play
- 3. <u>Committee</u> The Club is run on a not for profit basis (it is a Community Amateur Sports Club CASC) and managed by the Squash Club Committee which meets regularly. Members' input and views are welcomed
- 4. <u>England Squash</u> Parents/ Guardians will need to administer their child's England Squash records until they are 16 years of age, at which point they can administer their own. England Squash considers age 19 as an adult
- 5. <u>Booking Courts</u> A junior email address is needed for the junior to be able to manage their Clubnet user id and book courts in their own right. This is to allow the setup and rest of a password.
